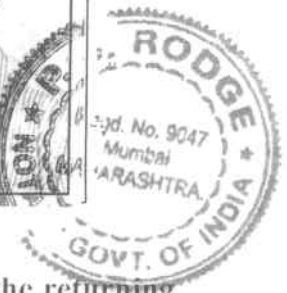

Election Commission of India and other, regarding the filing of incomplete affidavit of candidates, the candidates are required to fill up all columns therein. No column can be left blank. At the time of filling affidavit, RO has to check whether all columns of the affidavits filed with the nomination paper are filled up.
