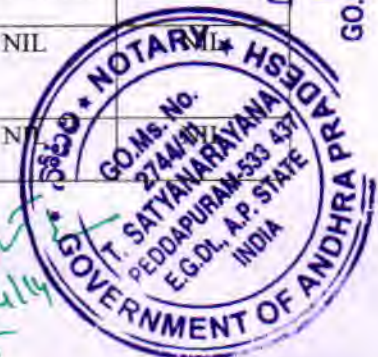

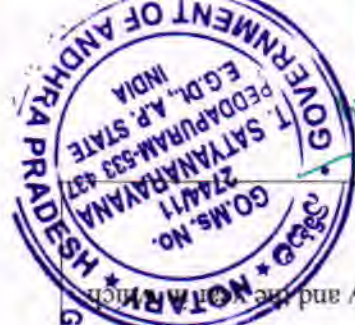

Note 5 : In pursuance of the Judgment date 13.09.2013 of the Hon'ble Supreme Court in WP(C) No. 121 of 2008-Resurgence India Vs Election Commission of India and other, regarding the filling of incomplete affidavit of candidates, the candidates, the candidates are required to fill up all columns there in No column can be left blank. At the time of filling of affidavit, RO has to check whether all columns of the affidavit filed with the nomination paper are filled up. If not, the RO shall give a reminder to the candidate to furnish information blank columns.
